No written order was transmitted to the Clerk of Court and the confidential materials were made available to the public by posting on the Clerk's docket Friday evening.

Because this case has been the focus of widespread public attention, the parties have a substantial concern that further avoidable breaches of confidentiality will occur, if the Clerk is not directed to take immediate action to seal the two filings at issue as soon as possible.


The specific filings are:
