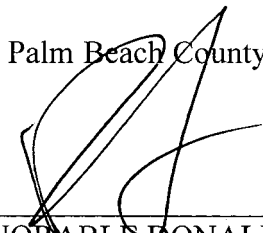
**ORDER ~~GRANTING/DENYING~~ DEFENDANT SCOTT
