**MOTION TO COMPEL RESPONSES TO INTERROGATORIES OVER THE
OBJECTIONS OF COUNTER-DEFENDANT JEFFREY EPSTEIN**

BRADLEY J. EDWARDS, by and through his undersigned attorneys, moves this Honorable Court to enter an order compelling Counter-Defendant, Jeffrey Epstein, to answer Interrogatories propounded by Counter-Plaintiff, Bradley J. Edwards, over the Objections of Jeffrey Epstein, and states:

1. Counter-Defendant, JEFFREY EPSTEIN, filed Updated Responses to Net Worth Interrogatories propounded by Bradley Edwards. Almost all of the responses raise privilege objections and provide no substantive information.
2. The objections are not well-taken and should be overruled.

WHEREFORE, Counter-Plaintiff moves for an Order requiring Counter-Defendant to answer the Net Worth Interrogatories in full within ten (10) days from the date of the Order, and providing that if said Counter-Defendant fails to serve sworn answers within that time be subject to the provisions of Rule 1.380, Florida Rules of Civil Procedure, and a judgment by default entered in favor of the Counter-Plaintiff, or for such other relief as the Court may deem proper under the laws of the State of Florida and the Florida Rules of Civil Procedure.
