Dr. Kliman: This is the second tape we're making today; you know I realized that I didn't get your preference for what you would like me to call you.

Dr. Kliman: The time is now 3:27 and you were telling me when I asked you about other bad things that happened in college, you mentioned some thing's that were; sounded more like there in obstacles category rather than in harmful things like your soccer got in the way of international business and biology; but you finally finished international business with an A; and your gonna be taking biology so I was thinking of those as obstacles. While, the problems with your alcoholic drug abusing disappointing boyfriend whom you cared about so much that sounds like a stressful problem. Now...when you had those troubles with your boyfriend would you say that those were serious problems for you, emotionally?

[REDACTED] Emotionally, yes I cared about him but I mean you can only take so much; I mean I was with him, known him for like 5 years; and after a while you just kinda like... you realize like you love the person but your not in love with the person; and that's kinda like, kinda how what happened to me; like I loved him and I knew I wasn't in love with him that's not the person I wanted to be with. So I mean, I took me like 3 years to realize that; 2 1/2 years I mean the last like two years I mean there was really nothing there I just kinda of kept going back to the like same old same old and after a while you just, I don't know; I didn't want to be with him anymore.

Dr. Kliman: What emotional reactions did you have to this change in your relationship?

Nothing really, I mean its not like I was around him all the time because I lived in Boca and he was living in Jacksonville. So it wasn't like he was around all the time for me to like really be disappointed because when I went to college I was single, I was by myself. I was going up to Jacksonville pretty much like every weekend though to go visit him, but I was used to like being by myself throughout the week and like the girls on my team were there to help me and support me and like one of my roommate was kinda of like going through the same thing; so we were both kinda there for each other, and I don't know, I just have...I have a lot of good friends there to help me like, I was going out with my friends get my mind off of it and eventually that's when I met...I ended up meeting somebody else he kinda filled that void for me.

Dr. Kliman: How long did it take you between the time of the restraining order and the time of meeting someone else?

Well...I got the restraining order when I was probably like 17 years old; and I got back together with Preston when I was probably around 18. So its not like the restraining order was what made me stop seeing Preston. I met Allan, I knew Allan...my new boyfriend; I met him at the end; like the last week of college. He goes to my school.

Dr. Kliman: Last week of the first year of college?

Yeah

Dr. Kliman: Freshman year?

Yeah my freshman year so I didn't really know him; I only knew him for like a week and then Sophomore year when I got back to Lynn; I just like knew of him me and him were like friends. There was nothing there like freshman year; like we were just friends. Like when I would go out in Boca I'd see him out; and finally whenever I cut all ties with my ex-boyfriend I would go out all the time, go out with my friends and like we would hang out a lot more like in the beginning of my junior year. Is whenever things like were really good between me and Allan.

Dr. Kliman: Does he spell his name with an "E"?

I mean I got over it probably like a year and a half after his death, like two years. Like it always still bothered, whenever I think about it; it always still bothers me on how like how he died and his life was taken at such a young age but it doesn't really like; I mean it's been so long; that it...I don't know. Like certain songs that remind me of him or...certain things that I'll think about but...

Dr. Kliman: Were you planning to get married?

[REDACTED] With him?

Dr. Kliman: Uh huh.

[REDACTED] No, that was never brought up.

Dr. Kliman: Would you say that it was a very serious relationship at the time?

[REDACTED] No more of a like good friends...and then it just kinda like ended up being; we realized we weren't like a good relationship that we were better off as friends so; whenever we broke up it wasn't anything like I hate you, it was just kind like...

Dr. Kliman: So you had actually broken up before he died?

[REDACTED] Yeah.

Dr. Kliman: Okay, now any other bad things that have happened in your life?

[REDACTED] I mean between my ex and my two friends dying. It's really...

Dr. Kliman: There was another one I forgot to ask you about...tell me of your other friends' death?

[REDACTED] My friend Jen, when I grew up Jennifer [not audible] she... I grew up with her, she lived right down the road from me and I was really close with her like cause growing up I would always go to High School parties and we would always hang out and like whenever I would have people come over to my house for a get together; she would come over and whenever she ever had people at her house I would always go over there, she lived right down like around the corner from me. We grew up like; she was like a year older than me, so like growing up we would always hang out but then there was that time whenever like...we didn't hang out with each other but whenever I got into High School we hung out again a lot more, we were really close. It wasn't her fault she wasn't drinking and driving but she was...there was a truck driver and he was like sleeping and supposedly

and they said they he had alcohol in his blood. They ran her off the road, and she went to swerve and she had two friends in the backseat which I'm friends with now and she ended up getting hit and got the worst of it ended dying. That was, that was hard because that was like my really good friend, like that, I mean it was just...I don't know, it was really weird how it happened I was like in shock for the first two months, I didn't believe that had happened. Cause I remember like; I ended up getting in a car accident with my ex boyfriend Preston, we were going down like a 25mph lane or whatever and he was doing probably like 60 when he went to hit the turn he ended up flipping the car that I was in; and the car that I was in, got totaled. And I remember being back at...like the next week nothing had happened I was completely fine I remember sitting there talking to her; like yeah...she's like you're so lucky that nothing happened to you and; just like sitting there talking about how fortunate I was that nothing happened and then like a week later after just having a conversation I remember like hearing about news and I just...I couldn't believe it. It was kinda like....I don't know it was so weird.

[REDACTED] Probably 17, I don't remember.

Dr. Kliman: And a week later...

[REDACTED] It seemed like it, it might not have been like a week, it might have been like a month; but it seemed like a week after I was just talking to Jen that she had gotten into an accident.

Dr. Kliman: That she was killed. Was she the driver when she was killed?

[REDACTED] Uh huh

Dr. Kliman: So these were shocking experiences?
