
ORDER ON MOTION FOR RECONSIDERATION

Cooper Tire & Rubber Co.* (citation omitted) in regard to this Court's Order sustaining Plaintiff's Objections to Discovery Requests. Based upon the foregoing, it is

Initially, this Court would note that the decision in *Alvarez* is still on Rehearing and, therefore, it is not a final opinion. Nevertheless, based upon argument of counsel, BRADLEY J.
