


PROBABLE CAUSE STATEMENT	<p>Upon arrival I made contact with the cab driver John Bespinis. Bespinis advised me he was driving Preston S Vinyard and _____ to _____ when they started to argue because neither of them had money to pay the cab. At some point during the argument, Bespinis said Vinyard hit _____. Upon arriving at _____ and Vinyard got out of the vehicle and ran into the residence. I walked up to the front door and noticed it was partially open. Shortley after Sgt.Murphy and Ofc.Doerr arrived to assist me. I knocked on the door several times and said "Police", but no one answered. Myself, Sgt.Murphy, and Ofc.Doerr entered the residence to make sure no one was injured. As I entered the residence _____ stepped out from behind a wall with a pair of shorts on and no shirt exposing her breasts. _____ told us to get out of her house numerous times. I advised _____ to put a shirt on and she did so. I tried to explain to _____ why we were there, but she kept telling us to get out of her house, and that no one was in her house. _____ then called her father, _____ and told him police were in there house for no reason. I then got on the phone with _____ and informed him of the situation. Since _____ was a juvenile, I asked _____ for consent to search his residence for the battery suspect. _____ agreed to let us search the house, but _____ would not let us search her fathers bedroom and locked herself in there. _____ stayed on the phone with her father and kept telling him she wanted us out of there house. We talked back and forth with _____ for about thirty minutes and I tried to have her open the door. _____ then told her father she was going to kill herself. Sgt.Murphy advised the father that since she made that statement we had no choice but to force entry into the room if the door was not opened. _____ advised he was on the way home from Ft.Pierce and that he will be home as soon as possible. _____ then opened the door and was placed in handcuffs for our protection. I then sat _____ on the couch in the living room while Sgt.Murphy searched the bedroom and discovered Vinyard under the bed. Vinyard was placed in cuffs and sat down on the couch in the living room. After running Vinyard by his Florida Drivers License, he came back with a Protection Order for _____. Shortley after _____ arrived home and was updated on the situation. Vinyard was placed under arrest for Violation of Protection Order and transported to the county jail without incident. _____ advised Vinyard did not hit her at any time, and refused to prosecute. Bespinis had left the scene earlier and when contacted refused to return to _____ to identify Vinyard or to prosecute for theft of services.</p>


