
**JEFFREY EPSTEIN'S ANSWER TO EDWARDS' AMENDMENT TO  
PARAGRAPH 32 OF EDWARDS' THIRD AMENDED COUNTERCLAIM**

Plaintiff Jeffrey Epstein, by and through his undersigned counsel and pursuant to Rule 1.190 of the *Florida Rules of Civil Procedure*, hereby amends his Answer to Paragraph 32 of Edwards' Third Amended Counterclaim by striking his previous Answer to Paragraph 32 and substituting the following in its place:

32. Epstein admits that he amended his Complaint over the course of this litigation, and that some counts contained in his Complaint were dismissed *by the Court without prejudice*. However, Epstein denies that this constitutes abandonment of his claims and/or a bona fide termination of his claims in Edwards' favor. Epstein further denies that his *first* filing of a Notice of Voluntary Dismissal, *without prejudice*, constitutes a bona fide termination of the case in Edwards' favor, and as such denies that allegation. Epstein denies any and all remaining allegations contained in Paragraph 32 and demands strict proof thereof.
