I was dispatched to [REDACTED] in reference to a battery. Upon arrival, I met with [REDACTED], who stated that while she was with her boyfriend at 147 Rivera Ave., they began arguing. Her boyfriend, Mr. Preston Vinyard, grabbed her around her neck and began spitting on her, accusing her of cheating on him. [REDACTED] stated that when she tried to leave, she tried to bite him and get away, but he bit her on the finger. I observed that [REDACTED] upper lip was beginning to swell up, and her finger was bruised. [REDACTED] stated that she did not want to prosecute Preston for battery. Information was given to [REDACTED] about seeking a restraining order. Preston is apparently living at 147 Rivera Ave. at this time. He was not at the residence at the time of this report.
