All three victims stated that they were riding bicycles on Thornbank at Dalmany. A w/m in a brown or gold 4 door vehicle stopped to ask directions. All three victims noticed that the w/m was exposing himself and fondling himself in front of them. They fled and went to 1308 Elmbank Way and called 911. Sgt. Pervenecki, Capt. Stepnowski and I checked the area for the suspect with negative finding. [REDACTED] father and [REDACTED] mother present during statements. [REDACTED] gave permission to me via landline for [REDACTED] to witness [REDACTED] statements. Prosecution affidavit's signed a witnessed.

[REDACTED] stated that she saw the w/m described in the report "wiggling his thing around" in the vehicle. She told me that this meant the man had his penis in his hand. She told me that she could not identify the man if she saw him again. She had nothing to add about the description of the car or suspect.

[REDACTED] told me that she did not see the suspect's penis. She was told by [REDACTED], but did not personally see him touching himself. She told me that the vehicle had a "ying/yang" decal on the vehicle's rear window and a "disco ball" (mirrored ball) hanging from the rear view mirror. [REDACTED] stated that she could identify the suspect if she saw him again.

I later talked with victim [REDACTED] at her home on [REDACTED]. [REDACTED] stated that he never saw the suspect's penis and that she really didn't get a good look at him. She gave a similar physical description but stated that she probably could not identify him again if she saw him. She stated that she could identify the vehicle.

I prepared a BOLO with the limited information I had. I also BOLO'd the area for three consecutive nights.

This vehicle has been seen one other time since the reported incident. To date, there have been no other sightings of this vehicle.

This case inactive until further leads become available.
