ON THE ABOVE DATE AND TIME I WAS DISPATCHED TO [REDACTED] STREET, REGARDING A TRAFFIC CRASH, VEHICLE VS TREE. UPON ARRIVAL I MADE CONTACT WITH THE VICTIM ROBERT WHO ADVISED A WHITE MALE, LATER IDENTIFIED AS PRESTON SCOTT VINYARD, W/M DOB 04/05/80, WAS ONE OF THE OCCUPANTS IN THE VEHICLE THAT CRASHED INTO HIS PALM TREE AND DAMAGED HIS LAWN AND LAWN ORNAMENTS. HE STATED HE OBSERVED A WHITE FEMALE EXIT THE VEHICLE AFTER IT CAME TO A STOP NEXT TO HIS RESIDENCE, THE FEMALE LATER IDENTIFIED AS THE PASSENGER, [REDACTED] RAN ON FOOT AWAY FROM THE SCENE. HE THEN STATED THE WHITE MALE THEN EXITED THE VEHICLE. ROBERT WENT TO PREVENT THE DEFENDANT FROM LEAVING THE SCENE OF THE CRASH AND STRUGGLED WITH HIM ON THE GROUND, BEFORE THE SUBJECT FLED ON FOOT BEHIND THE RESIDENCE. A COMPUTER CHECK OF THE VEHICLE IDENTIFIED THE REGISTERED OWNER AS, ANTHONY HERNANDEZ. CONTACT WAS MADE WITH HERNANDEZ, AT HIS RESIDENCE, WHERE HE WAS ASLEEP.
