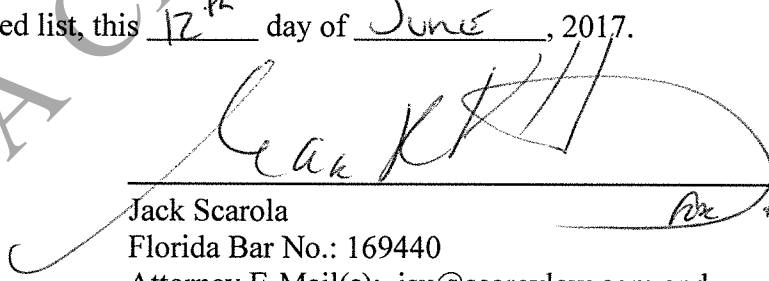

concur.

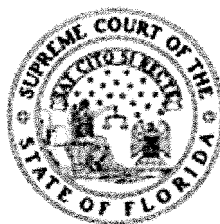
