**ORDER ON EMERGENCY MOTION BY L.M., E.W., AND JANE DOE TO
INTERVENE TO PROTECT CONFIDENTIALITY OF THEIR PRIVILEGED AND
OTHERWISE PROTECTED MATERIALS AND TO SEEK OTHER APPROPRIATE
REMEDIES**

This cause came before the Court for hearing on March 8, 2018, upon unopposed emergency motion by sexual assault victims L.M., E.W., and "Jane Doe" (hereinafter "the three victims"), proceeding pseudonymously, to intervene to protect the confidentiality of their asserted privileged and otherwise protected materials and to seek other remedies.

Good cause having been established in the motion that the three victims have interests in their privileges, protections, and confidentiality interests in various materials at issue in this case, and in light of Florida Rule of Civil Procedure 1.230 allowing "[a]nyone claiming an interest in pending litigation may at any time be permitted to assert a right by intervention," and no opposition having been advanced by either party in this case, the three victims are allowed to intervene in this case. The three victims are allowed intervention to assert protections regarding confidentiality of materials they argue are privileged or are otherwise protected and to seek appropriate remedies

concerning these materials, the possible inappropriate release of these materials, and protections relating to these materials.

ORDERED AND ADJUDGED that the Motion to Intervene is GRANTED.
