ON 03/09/07 AT APPROXIMATELY 1429 HRS., CPL. C. COHEN-ID# 4791, AND I RESPONDED TO 7448 LK WORTH RD., AT THE COLONY VILLAGE MOTEL, UNINCORPORATED LK WORTH, IN REFERENCE TO ASSISTING PROBATION OFFICERS IN APPREHENDING A PERSON WANTED FOR VIOLATION OF PROBATION.

UPON ARRIVAL I MET W/DEPT. OF CORRECTIONS OFFICERS HANNAH BYRNE-ID# 1954 AND DPETER FELDMAN-ID# 1822, WHO STATED THAT THEY HAD A VIOLATION OF PROBATION WARRANT FOR 2 SUSPECTS IDENTIFIED AS ARON KETELAAR AND [REDACTED].

UPON PLACING ARON UNDER ARREST FOR VIOLATION OF PROBATION. ARON ADMITTED TO ME THAT HE HAD A PLASTIC BAG OF MARIJUANA IN THE TOP DRESSER DRAWER LOCATED IN HIS MOTEL ROOM #122. OFFICER HANNAH THEN RETRIEVED THE PLASTIC BAGGY OF SUSPECTED MARIJUANA, IDENTIFIED AS A GREEN LEAFY SUBSTANCE IN A PLASTIC BAGGY. I CONDUCTED A MARIJUANA FIELD TEST USING A DUQUENOIS MARIJUANA TEST KIT. THE TEST REVEALED A POSITIVE RESULT FOR MARIJUANA. THE MARIJUANA WAS THEN WEIGHED USING AN OHAUS TRIPLE BEAM BALANCE SCALE AND WEIGHED APPROXIMATELY 7 OZ.

AT THIS TIME I FOUND ARON IN VIOLATION OF FSS 893.13(6B) POSSESSION OF MARIJUANA UNDER 20 GRAMS. I THEN PLACED ARON IN HANDCUFFS BEHIND HIS BACK AND CHECKED FOR PROPER FIT AND DOUBLE LOCKED THEM. I THEN TRANSPORTED ARON TO COUNTY JAIL W/OUT INCIDENT.

THE MARIJUANA WAS PLACED INTO PBSO EVIDENCE. THIS REPORT WAS CLEARED BY ARREST.
