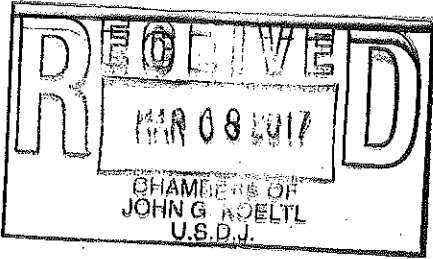

Dear Judge Koeltl:

We represent Jeffrey Epstein and are in the process of being engaged by Lesley Groff in the above-referenced matter. We write this letter jointly on behalf of the plaintiff and Mr. Epstein and Ms. Groff to request an adjournment of the initial case management conference currently scheduled for March 9, 2017 at 4:30 p.m. Subject to the Court's approval, the parties request an adjournment of the conference to April 6, 2017, or to any date thereafter which is convenient to the Court.

The grounds for seeking this adjournment are as follows. First, we have only just been retained by Mr. Epstein and have not yet formalized our engagement with Ms. Groff. Second, while service on Mr. Epstein and Ms. Groff has not yet been completed, we have agreed today to accept service on their behalf without prejudice to any defense they may have in connection with this lawsuit. Third, the plaintiff has not yet completed service on any other defendant and needs additional time to do so. Fourth, we need time to familiarize ourselves with the underlying matter. Finally, the parties make this application jointly.

Under these circumstances, and for reasons of efficiency, we request an adjournment of the conference to April 6, 2017, or to any other date thereafter which is convenient for the Court. This is the first time any party has requested an adjournment of the conference.
