**ORDER SETTING HEARING**

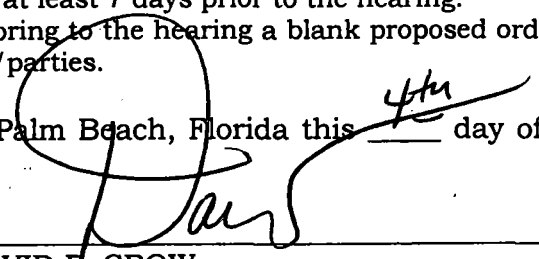
